

TVCRP DATA PRIVACY POLICY

1. Who are we?

2.1 We are the Tyne Valley Community Rail Partnership (TVCRP). We can be contacted at Tyne Valley Community Rail Partnership, Hexham Railway Station, Hexham, Northumberland NE46 1EU and secretary@tvcrp.org.uk and 01434 344383.

2. About this Policy

- 2.1 This policy explains when and why we collect personal information about our Board members and invited guests, and members of the TVCRP, how we use it and how we keep it secure and your rights in relation to it.
- 2.2 We may collect, use and store your personal data, as described in this Data Privacy Policy and as described when we collect data from you.
- 2.3 We reserve the right to amend this Data Privacy Policy from time to time without prior notice. You are advised to check our website (https://www.tvcrp.org.uk) regularly for any amendments (but amendments will not be made retrospectively).
- 2.4 We will always comply with the General Data Protection Regulation (**GDPR**) when dealing with your personal data. Further details on the GDPR can be found at the website for the Information Commissioner (www.ico.gov.uk). For the purposes of the GDPR, we will be the "controller" of all personal data we hold about you.

3. What information we collect and why.

- 3.1 Please note that in the following table we will only ever share anonymised data such as the number of members, the number of members within a Post Code etc. We will never disclose any personal details such as name, address, email address or telephone numbers.
- 3.2 We may also share such anonymised data with third party grant funders or other sources of grants where such data is required as part of the grant conditions.

We will seek the Member's or Director's consent at first membership or each membership renewal form or subsequently and the Member or Director may withdraw their consent at any time by contacting us by e-mail or letter.
The Director's or Board Member's name and e-mail address.	Creating and managing TVCRP online access to the website for the Director or Board member.	For the legitimate purposes of the operation of the TVCRP Board.
The Member's name and e-mail address.	Contacting members with TVCRP news e.g. via MailChimp or similar. Contacting members to conduct TVCRP surveys e.g. by SurveyMonkey or similar.	Consent. We will seek the Member's consent on their membership application form and each membership renewal form or subsequently. The Member may withdraw their consent at any time by contacting us by e-mail or letter to tell us that they no longer wish their details to used in this way by TVCRP or for those details to be held by TVCRP at all.

3.3 Data relating to images. Guidance from the Information Commissioner suggests that in order for an image to amount to personal data, it must be possible to identify an individual from information within the image or text associated with the image. Being recognised by family or friends is not the same as being identified. As a result, crowd or distance shots are unlikely to amount to personal data. If it is possible to identify the individual, perhaps as a result of additional information contained in the image, the image will be considered personal data for the purposes of data protection legislation.

For the purposes of this policy images and video will include:

- 1. Images of individuals at a TVCRP organised event
- 2. A staged picture of an individual e.g. at a TVCRP organised event taken to use in marketing material including the website and Social Media.

It does not include a picture of a crowd of people in which the individual(s) themselves cannot be explicitly identified.

We will make it clear that such images become the ownership of TVCRP but that the use of such image data may, like any other data, be withdrawn at any time. If such images were to be utilised on printed promotional material the withdrawal of such images will only be practical at the next print run of the printed material.

4. How we protect your personal data

- 4.1 We will not transfer your personal data outside the EEA.
- 4.2 We have implemented generally accepted standards of technology and operational security in order to protect personal data from loss, misuse, or unauthorised alteration or destruction.
- 4.3 Please note however that where you information is transmitted over the internet this can never be guaranteed to be 100% secure.
- 4.4 For any payments which we accept from you online we will use a recognised online secure payment system. Third parties will be used for this and TVCRP will not collect personal details in reference to payments.
- 4.5 We will notify you promptly in the event of any breach of your personal data which might expose you to serious risk.

5. Who else has access to the information you provide us?

- 5.1 We will never sell your personal data. We will not share your personal data with any third parties without your prior consent (which you are free to withhold) except where required to do so by law or as set out in the table above or paragraph 5.2 below.
- 5.2 We may pass your personal data to third parties who are service providers, agents and subcontractors to us for the purposes of completing tasks and providing services to you on our behalf (e.g. to print newsletters and send you mailings). However, we disclose only the personal data that is necessary for the third party to deliver the service and we have a contract in place that requires them to keep your information secure and not to use it for their own purposes.

6. How long do we keep your information?

6.1 We will hold your personal data on our systems for as long as you are a member of the TVCRP and for as long afterwards as is necessary to comply with our legal obligations. We will review your personal data every year to establish whether we are still entitled to process it. If we decide that we are not entitled to do so, we will stop processing your personal data except that we will retain your personal data in an archived form in

order to be able to comply with future legal obligations e.g. compliance with tax requirements and exemptions, and the establishment exercise or defence of legal claims.

7. Your rights

- 7.1 You have rights under the GDPR:
 - (a) to access your personal data
 - (b) to be provided with information about how your personal data is processed
 - (c) to have your personal data corrected
 - (d) to have your personal data erased in certain circumstances
 - (e) to object to or restrict how your personal data is processed
 - (f) to have your personal data transferred to yourself or to another business in certain circumstances.
